AUTHORIZATION TO PARTICIPATE IN A REGROUPMENT TO VERIFY JUDICIAL RECORDS

WHEREAS, Article 261.01 states that: "Before hiring persons who would be required to work with minor students or be regularly in contact with them, the school board must ensure that they have no judicial record relevant to the functions that could be assigned to them within that school board.

To that end, those persons must send a declaration concerning their judicial record to the school board. The school board must verify the declaration or have it verified."

WHEREAS those persons being considered for hire and/or as a volunteer must also provide a judicial record;

WHEREAS Riverside School Board can save 20% of its costs by joining with a group of school boards to have these verifications done by an outside agency;

WHEREAS this resolution was reviewed and is supported by the Human Resources Committee:

IT IS MOVED by Commissioner Capobianco Skipworth, seconded by Commissioner Horrell, that the Council of Commissioner support Riverside's participation in this regroupment plan.
