

KEY INSIGHTS TO KEEP IN MIND



Alcohol, drugs and other substances

The use, sale and distribution of illicit drugs are strictly prohibited. This includes non-prescribed medications for which a prescription is legally required are strictly prohibited. The consumption of alcoholic beverages is also prohibited on school board property and during all school or school board sanctioned events.

If a student is caught with drugs:

- · The parents are notified.
- The police are called.
- The student is suspended from school.
- Based on police intervention, there may be additional consequences at school, or police determine the legal consequences.







KEY INSIGHTS TO KEEP IN MIND

SCHOOL APPLICATION

Any student found in possession of illegal drugs will be dealt with in accordance with Riverside School Board's Policy to Maintain a Safe, Respectful and Drug-Free Environment in Schools.

KEY INSIGHTS TO KEEP IN MIND

CANNABIS ACT

The purpose of this <u>Act</u> is to prevent and reduce the **harms** associated with cannabis use. The goal is to ensure the security and well-being of the general public with a special focus on youth.

It is **prohibited** for a person **under 21** years of age to purchase, possess cannabis or distribute cannabis.

Potential Legal Consequences

- Fines
- Court Appearance
- Mandatory Placement
- Detention Centre
